How Do I Apply?

1. Complete one application per family and drop off at reception at the Juan de Fuca Recreation Centre, 1767 Island Highway, Victoria BC, or call 250-478-8384 with any questions.
2. Provide current proof of residency with you, such as a utility bill, rental agreement or government ID.
3. Provide 2023 or 2024 Notice of Assessment as proof of individual/gross annual family income. A copy may be obtained through Revenue Canada at 1-800-959-8281 or <http://www.cra-arc.gc.ca/myaccount>.
4. LIFE Cards will be issued to each member of an eligible family and are valid for one calendar year: January 1, 2025 - December 31, 2025.
5. Newcomers to Canada do not require a NOA. Please provide official travel documents for each family member.

CHOOSE ONE OF THE FOLLOWING DISCOUNTS

Option 1 **Drop-in and Registration Discount**
Receive all of the following discounts:

A. 52 free drop-in admissions at WSPR AND 52 free drop-in admissions at any Greater Victoria Recreation Centre for use at West Shore, Saanich, City of Victoria, Oak Bay, Panorama, Esquimalt and SEAPARC.

- LIFE card must be presented at the time of admission.
- One card is issued once per year for each family member.

AND

B. 50% off (up to \$50 reduction) 4 times per year on West Shore Parks & Recreation registered programs or discounted memberships and 10x and 25 visit passes.

- Some restrictions apply.
- A 'registration discount' may be used for 50% off a Juan de Fuca 55+ Senior's Centre Membership.
- Should LIFE clients use up all 52 drop-in admissions, they may purchase any general visit pass (e.g., 10x, 25x, etc.) at 50% off, to a maximum of \$50 off, or a 1-month, 3-month, annual, or regional annual membership pass at 50% off.

Option 2 **Annual Membership Pass Discount**
Receive the following discount:

A 50% reduction on a West Shore Parks & Recreation Annual Pass OR a Regional Annual Pass
Annual Pass for use at West Shore Parks & Recreation facilities ONLY.
Annual Regional Pass for use at 14 Greater Victoria Recreation Centres (does not include YMCA-YWCA).

- Monthly payment plans available; Visa/MasterCard/AMEX and automatic debit from your chequing account are accepted.

*Option 2 does not receive the 50% discount off programs, memberships or visit passes 4 times a year.

Other Information:

- LIFE passes are non-transferable, and are not eligible for cash or credit.
- All eligible WSPR LIFE members may book a free JDF weightroom orientation with reception.
- Participants must have their picture taken for their LIFE card.
- \$5 + tax replacement charge for lost cards.
- Replacement cards will be provided by subtracting 4 visits a month from January up to date card is replaced.
